We the Undersigned all citizens of the State of New York begin desirous of forming a corporation for the purpose of erecting, establishing, mainting and operating a hospital for the receiption, care, maintenance, giving of medical and surgical advice, aid and treatment of persons afflicted with maladies or physical injuries or physical weakness or deformities or infirmities as authorized by chapter ninety-five of the laws of 1889, passed by the Legislature of the State of New York entitled "An act to authorize the formation of Corporations for the establishment and maintenance of hospitals, infirmaries, dispensaries and homes for invalids or aged and indigent persons," approved by the Governor, March 29th 1889, and acts and laws amendatory hereto do hereby certify and declare I. That the Corporate name of such corporation shall be The City of Kingston Hospital II. That the objects for which such corporation is formed are to erect, establish, maintain and operate a hospital for the receiption, care, maintenance, giving of medical and surgical advice, aid and treatment of persons afflicted with Maladies or physical injuries or physical weakness or deformities or infirmities and to render medical and surgical aid, advice and treatment to poor persons in need of such treatment without charge therefor. III. That the affairs of such corporation are to be managed, conducted and administered by a board of Managers Consisting of nine persons and that the names of the persons who form the board of Managers of said Corporation for the first year are as follows, to wit: James A. Betts, Richard L. Burtsell, Jacob Chambers, Frederick J. R. Clarke, Patrick J. Flynn, William M. Hayes, John E. Kraft, John McEntee, George C. Smith IV. That the term of duration of such corporation shall be perpetual V. That said Hospital is to be located in the City of Kingston, County of Ulster and State of New York.
