They were told that they Shall have their Answer in the Afternoon.
The Court Adjourned till Three of the Clock in the Afternoon,

The Answer of the Justices to the Indians ?
1 The Justices Take it Very well of them to Renew the Peace made By both the Ancesters, and that the Same be kept in friendship on both Sides as long as the sun and moon shine.
2nd The Justices Join heartily in Shaking hands with greatest friend Ship
3rd As to the Taverns the Justices Cannot Lessen the Number of them And advise you to Sobriety and to Mind their Hunting to Maintain Their familys. But if any white People Defraud or Cheat Them if they Complain and if Appearing So the Justices will See them Justice Done.
4.As to the Price of Goods on both Sides must be regulated according as Parties on both Sides Can Agree.
